## DeCS- Health Sciences Descriptors: license agreement and conditions of use

## 1. About DeCS

- 1.1 The structured and trilingual DeCS vocabulary Health Sciences
  Descriptors was created by the Latin American and Caribbean Center
  on Health Sciences Information BIREME, a specialized center of the
  Pan American Health Organization, the regional office for the
  Americas of the World Health Organization, hereinafter
  "BIREME/PAHO/WHO", from the MeSH Medical Subject Headings of
  the U.S. National Library of Medicine, with the objective of
  permitting the use of a controlled terminology both in the indexing
  and in the search by subject for technical and scientific literature in
  the LILACS, MEDLINE and other databases available in the Virtual
  Health Library ("VHL"), providing a consistent environment of
  recovery of information in health sciences in the region, regardless of
  the language.
- 1.2 DeCS integrates the LILACS methodology and is an integrating component of the VHL, is annually updated, and the utilization of the most recent version is promoted.

## 2. Terms and conditions of use

- 2.1 The user recognizes all the intellectual property rights of BIREME/PAHO/WHO, especially the authorship, with regard to DeCS, in the Portuguese, Spanish, and English languages.
- 2.2 The content of DeCS obtained from the MeSH-Medical Subject
  Headings is the property of the U.S. National Library of Medicine, that

- is recognized by BIREME/PAHO/WHO and by the user as creator, maintainer and supplier of the aforementioned content.
- 2.3 The user is permitted to use DeCS, in all the forms and media provided by BIREME/PAHO/WHO, including when part of other programs (software), as well as to make copies for personal or corporate use, forbidden the marketing and the modification of its content. In case of corporate use, the user must clearly identify BIREME/PAHO/WHO as the owner of the copyright, as well as the creator, maintainer, and supplier of the data.
- 2.4 The DeCS is brought up to date annually and the user must identify the version being used (example: DeCS 2008 version), as well as is requested to always obtain and use the most up-to-date version of the vocabulary.
